Tenure of Appointment: The appointment for the above contractual position will be initially for 02 (two) months, which can be further extended subject to satisfactory performance.

Job description: Data Collection, ML and RL Model Development, Any administrative works as per requirement

Age Limit: Not more than 28 years. Age relaxation as per SERB-DST and GOI norms.

Interested and eligible candidates are encouraged to apply by filling the application form. Selected candidates will be encouraged to join the Ph.D program at Indian Institute of Information Technology Dharwad as per the institute norms and availability of funds.

Details of the Selection Process:

Shortlisted candidates and date of selection process will be intimated over email. Applications will be screened initially. Only the shortlisted applicants will be called for an interview. The shortlisted candidates may be asked to undergo a written test followed by the interview via online/telephone mode. Mere fulfilment of minimum eligibility will not bestow the right for short listing. IIIT Dharwad reserves the right to screen and shortlist candidates by introducing higher benchmarks. Emails will be sent to all shortlisted candidates.



Documents Required: Applicant should have online version of all original certificates including mark sheets (matriculation onwards), degree certificates, experience certificate(s), other relevant documents (including one set of self-attested certificate(s)/document(s) and updated Curriculum Vitae.

Terms and conditions

1. Selected candidates shall not have claim on any regular position and shall not be bestowed any of the privileges like Housing, Medical Facility and Other benefits available to regular employees of the Institute.
2. Applicants are advised to ensure, before appearing for the Selection Process, that they possess the minimum essential qualification and experience laid down for the post. Qualification obtained has to be from a recognized University/Institute. Eligibility in terms of age, qualification and experience of a candidate shall be considered as on the date of Selection Process.
3. The number of vacancies indicated in the notification is tentative. IIIT Dharwad reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIIT Dharwad reserves the right to NOT fill any of the posts advertised.
4. No TA/DA will be paid for attending the Selection Process.
5. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to modify, withdraw or cancel any communication made to the Applicants.
6. After joining the service of the Institute, the person(s) will have to abide by the Rules, Regulations, Ordinances, Statutes and Act of the Institute applicable from time to time. He/ She may be assigned any duty within or outside the Institute depending upon the exigency of the work.
7. The Institute shall verify the antecedents or documents submitted by a person at the time of appointment or during the tenure of the service. In case it is detected that the documents submitted by the candidates are fake, or the person has a clandestine antecedents or background and has suppressed the said information, then his/her services shall be terminated forthwith and legal action may be initiated against such candidates/employees.
